

### **VISION**

+ + Through 100% advocacy every child is **nurtured**, **supported**, and **has access** to connections and resources necessary for them to know their value and reach their full potential.

### **EQUITY INITIATIVE**

Our mission of 100% advocacy for local children has always been approached to ensure the equitable distribution of resources to advance permanence, normalcy, and safety for each child for whom we advocate. This year, we joined dozens of local nonprofit and governmental bodies and more than 350 individuals in an explicit pledge of commitment to racial and social equity by participating in Palm Beach County's Advancing the Mission (AIM) Initiative.

Through this experience, Speak Up for Kids Board of Directors applied a top-down approach in using equity tools and internal assessments to identify and update policies and institutional practices that lead to increased inclusion across all demographics while fully integrating an equity action into our overall Strategic Plan.

In addition to our action plan, we have also created the Speak Up for Kids GREEN **Equity Statement.**

**Speak Up for Kids of Palm Beach County, Inc.** rewrites the expected futures of children in care while serving as the exclusive 501(c)(3) fundraising arm for the **Guardian ad Litem Program of Palm Beach County, Florida.** 

The Guardian ad Litem Program uses court-appointed, one-on-one, best-interest advocacy on behalf of more than 1,500 local children. The 620+ 'Guardian Angel' volunteers present the best permanent security, shelter, and normalcy outcomes for dependency-involved cases.

In the face of seemingly insurmountable challenges, sometimes even heartbreak, we forge ahead, matching the intense perseverance and resilience of the children we serve. We face each challenge as an evolutionary opportunity to create a revolutionary impression, knowing that the impact is UNDENIABLE, MEANINGFUL, and PERPETUAL with each Child and Volunteer Advocate connection.

Our work in supporting the recruitment, training and retention of Guardian ad Litem VOLUNTEER CHILD ADVOCATES effectively breaks abuse, violence, and crime cycles and potentially transforms generations. However, only one-on-one advocacy can get to the heart of what is REQUIRED for a child to THRIVE.

This corps of greater than 620 Volunteer "Guardian Angels" is committed exclusively to each child's emotional, educational, and physical well-being throughout dependency court proceedings serving as the ONLY 100% objective voice, the eyes and ears of the court, and usually, the most consistent presence in the child's life.

### **GUARDIAN AD LITEM**

### **ADVOCACY**

My first assignment was for a seven year old girl. Her mother was her caretaker. Her father was deceased as a result of an overdose. The mother was using methadone, and was having a difficult time abstaining. The child was being neglected by her mother. However, four generations were living under one roof, so the child was getting by.

Visiting the home for the first time was a dark experience. No one was getting along, and you could cut the tension with a knife. The mother and her mother (the child's grandmother), had a particularly cold relationship. The mother and the child were basically holed up in a bedroom day and night as a result. It was overall a very depressing, and seemingly hopeless situation. Summer was coming and there were no planned activities at all for the child.

THAT HAS ALL CHANGED NOW. The child, with some urging and some help with facilitating enrollment, would spend the summer attending day camp. The child was dead set against the idea, but could not wait to return after her first day of attendance. Getting the child out of that house, and getting her to play with other kids, was a huge positive move. Her entire demeanor changed. The mother also seemed to be energized as a result. She went out and obtained a part time job, which she really likes. The child in turn saw the difference in her mothers demeanor. It was quite a dynamic change to observe. All of a sudden, tension lifted in that house, people were laughing, talking with one another and just plain happy. Both the child and mother are doing well now. It's actually a joy now to visit them in their house. I believe I will be involved with this family long after the case is closed. My lessons from just one assignment:

- Build a trusting relationship with both child and mother.
- Don't judge, but encourage and be supportive. Be consistent.
- · Work with the mother and child to help them see solutions, rather than just problems.
- Show respect to the mother, especially in front of the child.
- Be a good listener.
- Care; really care.

The rewards of being a GAL are great. You are actually blessed with the opportunity to help people change their lives for the better. You feel the weight of that responsibility, but when you have an outcome like the one I have just described, there is no better feeling in the world!

Central to PARENTS Speak Up for Kids is the Healing Hearts Podcast, which brings the mental health needs of foster children to the forefront.

Too often, victories achieved by foster-involved young people go unnoticed. **Growing Grads**, Speak Up for Kids' premier, three-pronged, milestone-focused program is aimed at celebrating the accomplishments of youth in care:

- **1. Graduation Celebration** Whether it's a GED, diploma, degree completion, or certificate, we celebrate with and for our kids.
- **2. Gift for Grads** We rally the community to full swag bags with gift cards and personalized items for our GRADS.
- **3. Celebrating YOUth Scholarship** The support systems inherent to traditional family structures aren't in place for the children we serve. These scholarships help bridge the gap and make 'next steps' more attainable.

#### **Therapeutic Court**


Born out of the idea that courts can "protect, serve justice, and be therapeutic," primarily related to the most complex cases. Therapeutic Court is a first-of-its-kind, round-table, team approach to advocacy. Through single weekly meetings, every agency involved in the child's case is represented and is monitored through Judicial oversight.

#### **Early Childhood Court**

Early Childhood Court exists to intervene in dependency cases as early as possible to establish safety, permanence, and Normalcy as soon as possible because infant

and toddler victims are, sadly, not spared the horror of child victimization and are least able to advocate for themselves.

This self-sustained, initiative-driven program uses a community-wide approach to build awareness of Palm Beach County's critical foster home shortage and connect potential foster parents with necessary credentialing agencies.

## THERAPEUTIC INTERVENTION & PERMANENCE

Austin and his sister Vivvy were born addicted to opiates and were adopted by their aunt and uncle when their mother's parental rights were terminated.

When Austin started kindergarten, the school began reporting concerns about his behavior. Sadly, this proved too much for his aunt and uncle, who returned him to state care.

It was then that the court assigned Judy as his volunteer child advocate. Judy worked to get various assessments performed and found a center specializing in play and various other therapies.

Because it was not covered by insurance, Judy looked for other resources, then contacted Speak Up for Kids for the funding needed to get Austin much-needed help.

Fast forward three years, and Austin is thriving in school. AND he has a new forever family.
